**श्री सभापति :** अभी वह दूसरे क्वेश्चन से साफ हो जायगा।

**SHRI M. R. KRISHNA:** Sir, the intention of the Minister is very clear to help the people who have served Defence forces and boarded out medically. But, generally, the General Manager is the boss there and if he does not like anybody, even though a person might have served for a number of years, he cannot get a job for his ward. Therefore, a system will have to be evolved. I would like to know "whether the norms which the Minister has just said, are followed by all the Ordnance factories under the DGOF; I would particularly like to know whether the Ammunition factory at Kirkee is following these instructions because I know for a fact that a scheduled Caste family which had devoted itself for 30 years in the service of this factory, has been deprived of this benefit even though the person was boarded out medically as he lost his eyesight and the family members, especially the lady who is fully qualified, had not been provided any job. I want to know whether these norms are followed in all the factories uniformly.

**SHRI SHIVRAJ V. PATIL:** It is very difficult for me to answer questions with respect to all the factories; this question was asked with respect of the factory at Muradnagar.

**SHRI M. R. KRISHNA:** There should be only one system.

**SHRI SHIVRAJ V. PATIL:** Criteria are laid down for recruiting the wards of the factory workers who are boarded out for medical reasons. Generally criteria given are followed by all factories and if any factory is not following them, we will look into it.
