- (a) whether it is a fact that carbolic soap has been treated to be a separate category besides toilet laundry soaps (for the consideration of pricing);

THE MINISTER OF STATE IN THE INDUSTRY MINISTRY OF (SHRI CHARANJIT CHANANA): (a) to (c) Soaps have been classified into two categories, namely, (i) Soap, household and laundry, and (ii) other sorts. Lifebuoy, a toilet soap manufactured by M/s. Hindustan Level Ltd., is included in the category of "other sorts" both for statistical purposes as well as for payment of excise duty.

# Implementation of the Agricultural **Workers Minimum Wages Act**

±2210. SHRI SHIVA CHANDRA JHA: Will the Minister of LABOUR be pleased to state what steps are being taken by Government to implement the Agricultural Workers' Minimum Wages Act effectively in the country during the Sixth Plan period?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR (SHRIMATI RAM DULARI SINHA): In order to ensure effective implementation of the Minimum Wages Act, with particular

reference to agricultural labour, the State Labour Ministers' Conference held in July, 1980 recommended the following steps to be taken in the matter which have been brought to the notice of all the State Governments for taking apropriate action.

to Questions

- (i) implementation of the minimum wages in agriculture should be pursued vigorously as an item of the 20-point programme;
- (ii) there should be a separate ma-chinery for imlementation of labour laws in general and implementation of minimum wages in agriculture in particular at district and taluk levels. Such machinery should take the assistance of the Revenue, Panchayat and other Departments, depending on the conditions in individual States.
- (iii) tripartite committees should be formed at different levels within the State to oversee the implementation of minimum wages in agriculture;
- (iv) the workers education program mes should be intensified rural areas to bring about an aware among the agricultural workers about their rights in regard to mini mum wages payable by the employer under the Minimum Wages Act.
- (v) steps should be taken to promote the organisation of labour in rural areas which would facilitate the implementation of minimum wages in agriculture.

Minister of State in the Ministry of Labour has also written to all the State Governments in this respect.

- (c) if so, what are the reasons for ignoring the eligible officers, i.e. Assis tant Surveyors of works and Assis having tant Executive Engineers re qualifications minimum quisite for promotion as Surveyor of works?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) 29 posts of Surveyor of Works are vacant under Engineer-in-Chief Branch from 1979.

- (b) 22 experienced Executive Engineers have been employed against these vacancies on an ad hoc basis.
- (c) Under the existing recruitment rules Assistant Executive Engineers are not eligible for promotion to the grade of Surveyor of Works. Amendment of the rules is necessary to include such Assistant Executive Engineers who had opted for absorption in the Surveyor cadre to make them eligible for promotion to the grade of Surveyor of Works. Regular promotion will be made as soon as the amendment is carried out.
