#### ORAL ANSWERS TO QUESTIONS

## Hospitals under the Employees' State Insurance Scheme

\*361. SHRI M. BASAVARAJU: Will the Minister of LABOUR be pleased to refer to the reply to Unstarred Question 285 given in the Rajya Sabha on the 20th August, 1981 and state the further progress so far made for opening of the proposed 49 hospitals under the ESI scheme?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR (SHRIMATI RAM DULARI SINHA): In April, 1981 when Hon. Member asked the question first about hospitals under the ESI, 24 hospitals and 8 annexes were under construction and action for construction of 49 more hospitals had been initiated.

The present position is as follows:

7 hospitals and 1 annexe with 1264 beds have since been completed and commissioned.

6 hospitals with 700 beds have been completed and are expected to be commissioned shortly.

11 more hospitals with 1130 beds, 7 annexes with 120 beds are under construction.

Plans and estimates in respect of 5 hospitals with 450 beds have been sanctioned and construction is expected to commence shortly.

Plots have been purchased for 16 hospitals with 1350 beds and plans and estimates are under preparation.

Plots have been selected in respect of 11 hospitals with 1000 beds and arrangements are being made for the purchase. Efforts to locate suitable plots in respect of 17 more hospitals with 1425 beds are continuing. Construction of 9 more hospitals with 475 beds have been approved in principle since August, 1981

SHRI M. BASAVARAJU: May I know what is the Statewise break-up of the proposed E.S.I. hospitals?

SHRIMATI RAM DULARI SINHA: Sir, the completed and commissioned E.S.I. hospitals are: ESI hospital, Thane; ESI hospital, Musore. ESI hospital, Baroda; ESI hospital, Patna; ESI hospital, Naini; ESI hospital, Lucknow; ESI hospital, Adityapur; and ESI Annexe at Kolar Coal Fields. The ESI hospitals to be commissioned shortly are: ESI hospital, Kelore in Gujarat; ESI hospital, Rajkot; ESI hospital,

Surat; ESI hospital, Agra; ESI hospital Ghaziabad and ESI hospital, Bandel in West Bengal.

SHRI M. BASAVARAJU: I would like to know whether the Government proposes to renew the entire ESI setup, especially regarding the inadequate medical facilities to workers under ESI.

SHRIMATI RAM DULARI SINHA: It is a continuing process. When the proposals come from the States for opening of hospitals and dispensaries, we look into the matter and then decide and for inadequacy of medicines Government always relieves and needful steps are taken from time to time.

SHRIMATI MONIKA DAS: I would like to know from the hon. Minister the categories of the workers covered by the Employees' State Insurance Scheme and whether there is any proposal under consideration to enlarge the scope of the scheme so that the workers working in small cities are also benefited.

SHRIMATI RAM DULARI SINHA: According to the ESI Act, the workers employed in establishments having 20 or more workers are covered under this Act. In some of the States where the establishments are run with power, 10 and up to 19 workers can be covered. There have been lots of discussions in our ESI Corporations and in standing committee. regarding the scope of this Act to expand it seasonal factories also. We are looking into the matter. A proposal has been received to cover the sugar industry workers also under this scheme. It is under active consideration of the Government.

SHRIMATI MANORAMA PANDE: I would like to know as to how many hospitals have been commissioned in Bihar.

SHRIMATI RAM DULARI SINHA: There is a long list. Very recently, our Labour Minister, Shri N. D. Tiwari, has been to Adityapur and he inaugurated that hospital. On 1st May,

1981, I inaugurated one Phulwari Shareef hospital. So, two hospitals have been commissioned during the year in Bihar.

MR. CHAIRMAN: Two more questions. One from Mr. Dhabe and the other from Dr. Siddhu.

SHRIDHAR WASUDEO SHRI DHABE: May I know from the Minister whether a Review Committee has been appointed for the extension of ESI hospitals and one of the reconimendations is to so amend the ESI Act and other matters that when the workers are on strike or there is a lock-out, they will not be entitled to the benefits of ESI scheme. Secondly, the main difficulty of the workers is that when the relatives come, there is no arrangement for their stay near the hospitals. Will the Minister make some arrangements for the relatives, stay near the hospital?

SHRIMATI RAM DULARI SINHAThe hon. Member is requested to repeat the question.

SHRI SHRIDHAR WASUDEO DHABE: Has there been any Review Committee appointed for extension of ESI facilities and other matters and whether one of the recommendations is that the workers, when they are on strike or when the industry is locked out, will not be entitled to ESI benefits? Secondly, will you make any arrangements for the relatives of workers so that they can stay near the hospitals?

SHRIMATI RAM DULARI SINHA: It was discussed in the Standing Committee and later on it was discussed in the Corporation. Nothing was decided about the workers who might be on strike. There was division of opinion. Some said that they should not be covered. Some others said that they should be covered. So, there was no unanimity in this regard.

SHRI SHRIDHAR WASUDEO DHABE: What about the stay of relatives of the workers near the hospital when they come to attend to him?

SHRIMATI RAM DULARI SINHA: Suggestions will be looked into.

SHRI SHRIDHAR WASUDEO.

DHABE: How can they be benefited by the scheme?

SHRIMATI RAM DULARI SINHA: I have already said that it will be looked into.

SHRI SHRIDHAR WASUDEO DHABE; My question is different.

MR. CHAIRMAN: His question is slightly different. Will you repeat it?

SHRI SHRIDHAR WASUDEO DHABE: When the relatives of the workers come to see the patients, there is no arrangement for their stay nearby. Is there any scheme for making some arrangements for the relatives?

SHRIMATI RAM DULARI SINHA: The hon. Member's suggestion will be considered sympathetically.

DR. M. M. S. SIDDHU: Sir. the ESI hospitals are being manned by the Medical Services from the States. Will the hon. Minister be pleased to state in how many hospitals the traumatology units which take care of the injuries are there and what provision has been made to take care of the injured people and for their rehabilitation hecause these two things are absent to my information? And I would like to know whether these facilities of traumatology units have been provided in the hospitals which the hon. Minister has just stated have been proposed or have been opened.

SHRIMATI RAM DULARI SINHA: For the injury also, there is a provision. And if there is no provision for that in any dispensary or hospital, then we send the workers to the main hospitals and the cost is borne by the Government.

DR. M. M. S. SIDDHU: This is not the question. Even in hospitals which they call as main hospitals, there is no trauma unit. I can say this. And, therefore, there is no specialist organisation.

MR. CHAIRMAN: Dr. Siddhu, you are using trauma units. She has translated it as injury wards. Trauma is something which you understand.

SHRIMATI RAM DULARI SINHA: Injury ward. For the serious injuries also, they are taken care of. They are given treatment.

MR. CHAIRMAN: You have got a ward?

SHRIMATI RAM DULARI SINHA: Yes, Sir.

रक्षा मंत्रालय वें राज्य मंत्री (श्री शिव राज बो श्री पाटिल) : (क) जी, हां।

(ख) ड.क्टरी बोर्ड की सिफारिशों के ग्राधार पर जिन कर्मचारियां को सेवा- मुक्त किया जाता है उनमें से कुछ ऐसे ग्रमाधारण मामलों में उनके बच्चों को रोजगार कार्यालय के माध्यम में नियुक्ति की सामान्य प्रक्रिया में छूट दे दी जाती है, जहां परिवार की हालत दयनीय हो ग्रीर उम्मीदवार मंबंधित पद के लिए भरती नियमों के ग्रनुस र हर प्रकार से उपयुक्त हो। ये नियुक्तियां समूह 'ग' तथा 'घ' पदों पर की जाती हैं वशर्तें इन समूहों में पद खाली हो।

(ग) श्रौर (घ) नवम्बर, 1980 तक डाक्टरी बोर्ड की सिफारिशों के श्राधार पर सेवामुक्त किए गए 27 कर्मचारियों में से 11 कर्मचारियों के वच्चों को रोजगार दिया जा चुका है, 7 मामले विचाराधीन हैं श्रौर 9 मामलों को विचार करने के बाद नामंजूर कर दिया गया है।

श्री कलराज मिश्र : सभापति महोदय, मैं मंत्री महोदय से जानना चाहूंगा कि मुराद-नगर में जो भ्रार्डनेंस फैक्टरी है उसमें जो कर्मचारी बोर्डेंड ग्राऊट हुए उनमें से कई लोगों के बच्चों को रख लिया गया लेकिन कई ऐसे हैं जैसे अभी आपने बताया कि इस प्रकार की चिकित्सा के ग्राधार पर या मेडिकल ग्राउंड पर जिनको म्रलग किया गया उनके ग्राश्रितों की नियुक्ति की गई है। उसके लिए मापदंड है लेकिन उस मापदंड के दौरान जो भी वचे हुए हैं जिनकी म्रार्थिक स्थिति दयनीय हैं उनके बच्चे उस प्रकार की योग्यता कम में स्राते है लेकिन उनको नहीं रखा गया स्रौर -कुछ लोगों को रख लिया गया जसे आपने ग्रपने उत्तर में भी बताया । लेकिन मैं यह जानना चाहता ह्ंकि म्रादनगर ग्रार्डनेस फैक्टरी में जिन के बच्चों को रखा गया है श्रौर जिनके वच्चों को नहीं रखा गर्य। है उनकी श्राधिक स्थिति का श्रांकलन करने के लिए कौन सा ऐसा फोरम या सैल है जिसने इस प्रकार की जांच कर के आंकड़े प्रस्तून किये । मेरी जानकारी के श्रनुसार इसमें जो लोग रखे गये हैं ग्रौर जो लोग नहीं रखें गये हैं उनकी अपेक्षा आर्थिक दृष्टि से बहुत अच्छे
