But I am not concerned with Mrs. Gandhi. I wanted to point out that she happens to be an opposition leader now at the national level.

Well, I do not know, now Mr. Morarji Desai has sent a message "Oh everything will be good, friendship will be strengthened," etc.-all kinds of rosy things he has said. He should know very well the Government should know very well that this Tory die-hard imperialist leader represents the racist forces and her coming to power would create problems not only for the Asians in the United Kingdom but also for the people who are fighting in Southern Afriagainst racist discrimination, apart from stepping up war preparations and arms race. So it is a matter of concern for us.

REFERENCE TO THE STEPPING UP OF THE POLICY OF DISCRIMI-NATION AGAINST ASIANS, PARTI-CULARLY INDIANS IN U.K. SOON AFTER MRS. THATCHER'S COMING TO POWER

SHRI SHIVA CHANDRA JHA (Bihar): Mr. Chairman, Sir, I want to draw your attention to a matter of great importance namely the policy of discrimination that is being started in England recently after the election of Mrs. Thatcher. You remember, that some days ago it was I who had pointed out to the Foreign Minister that India should be on her guard since Mrs. Thatcher was coming to power because she has already said that the policy of discrimination would speeded up and all the immigrants living in England would be ousted. To that Mr. Vajpayee had answered that when one is on the Opposition side one says something different but while on the Treasury Benches one becomes different. Sir, the matter is not different. She has come to power and just on the morrow of her victory she has started this policy of discrimination against the Asians in general and Indians in particular, Since Mrs. Thatcher has been called by the Queen and has formed the Government and since she is known for trampling upon the fundamental rights and human rights of Indian citizens in England, it is a matter of great importance that Government of India should take up the matter seriously. When the next Commonwealth Conference is held the

matter should be raised there. The Government of India should formulate her policy and come out of the Commonwealth.

Now, let us know the incident which took place. I just said that the discrimination policy is being pursued or rather is being accelerated by the Tory Government The Commonwealth, with their linkage throughout the world, have their Empire throughout the world. Recently there was an incident. If you go to England now you will not be allowed to have your cap on your head. You will not be allowed to have your Sherwani on your body. If you walk in the streets of England you will be told to go naked rather you will be rid of your dhoti also. Recently, there a boy was told not to wear his head dress. You know, Sir, in India many people not only Sikhs, use turbans. Even Gujaratis wear turbans there. You remember the photograph of Mahatma Gandhi with a turban on his head. So that boy has been told not to wear his turban. This is glaringly a discriminatory law by the England Government led by the newlyelected Tory Prime Minister, Mrs. Thatcher. Her basic aim is to have a policy of discrimination against the Asians in general and Indians in particular. Why I am saying all this is that this matter should be noted seriously and our Government should reappraise their policy vis-a-vis the policy of discrimination pursued by England. I would, therefore, say that they should come out of the Commonwealth.

REFERENCE TO THE ALIGARH MUSLIM UNIVERSITY (AMEND-MENT) BILL, 1979

SHRI G. C. BHATTACHARYA (Uttar Pradesh): Sir, on the 3rd of May the Lok Sabha passed the Aligarh Muslim

University (Amendment) Bill denying minority character to the University. Now Sir, because of that a serious situation has arisen. There was strike in the Aligarh University. They have decided to stage a demonstration before the Parliament House. have also decided and planned nationwide rallies, demonstrations, dharnas and hunger strikes to press the demand for restoring minority character to the Aligarh Muslim University. What is happening? This denial of the minority character to the Aligarh Muslim University is a very serious matter, particularly in the context of many other developments leading to this revivalism I should say the Hindu revivalism. There are apprehensions in the minds of the minorities, whether they are Christians or Mulims and there are good reasons for that. There were communal holocaust in Aligarh and also in Jamshedpur. There is again an attempt to amend the Constitution to empower the Centre protect the cow. Not only that, there is the so-called "Freedom of Religion The history text-books sought to be written in a way to give a communal character and to do away with the secular character. There is a concerted effort in the media the AIR and the TV, to give impetus to the religious part of the entire society so that an apprehension is created in the minds of the minorities that they have no place in the country. Such a serious situation has arisen.

So far as the minority character of the Aligarh Muslim University is concerned, you know that the minority character was inherent there because after the mutiny the Muslims boycotted the English education and the British empire. What happened? Certain Muslim leaders decided that it was not correct and that they should not remain outside the main stream. Therefore, to give them higher education and the English education they established this Muslim University. We have no right and nobody has any right to deprive that original character of the University. It is being done
