Among the scientists who have expressed themselves openly against the findings of this report are Professor T. Shivaji Rao of the Andhra Pradesh University and Prof. J. M. Dave of the Jawaharlal Nehru University. The Government is already seized of the matter and appropriate action would be taken.

(b) According to the available figures as on 31st December, the number of children upto 16 years of age in jails was 1007 (0.74 per cent of total). Details of their offences are however, not available with the Government of India.
