RAM KRIPAL SINHA): Sir, the statement given below reveals that while the number of serious accidents in non-coal mines during 1978 was not higher compared to 1977, there was a very marginal increase in the number of fatal accidents.

Out of 65 fatal accidents which occurred during 1977, as mentioned in the reply, one accident was, on further investigations by Directorate General of Mines Safety, found to be a non-mining one. The other one was included due to a clerical error.

Out of 65 fatal accidents which occurred during 1978, one accident was, on further investigations by Directorate General of Mines Safety, categorised as "dangerous occurrence" as there was no fatality.

The delay in correcting the reply is regretted.
