## REFERENCE TO THE REPORTED ACUTE SHORTAGE OF FOOD-GRAINS IN MIZORAM AND TRIPURA

SHRI LALSAWIA (Mizoram): Mr. Vice-Chairman, Sir, this is a matter of urgent public importance and so, Sir, I draw the attention of the Union Government to the reports that Mizoram and Tripura have been severely hit by an acute shortage of foodgrains due to the failure of the Food Corporation of India to maintain an adequate buffer stocks in these areas. Even wheat supplies through ration shops have been stopped for the last one month. If arrangements are not made immediately to store sufficient foodgrains in these regions, food scarcity will be worsened during the rainy season. Although now the time is a bit late to stock foodgrains, unless the Government takes this very seriously, once the monsoon sets in people in the interior will have nothing to eat. So, I have to bring this to the notice of the House.
