REFERENCE TO ACCORDING RE-COGNITION TO THE NEW GOVERN MEJVT OF UGANDA BY THE GOV-ERNMENT OF INDIA

SHRI N. P. CHENGALRAYA NAIDU (Andhra Pradesh); Sir, in Uganda, the fighting is over. The President, Idi Amin, has gone away to Libya. His forces are out. Mr. Nverere, the President of Tanzania, has announced that his forces have been withdrawn, that only the Ugandan forces were in control, that President Rule is in charge of the Government and that there were no other forces in that country. We have got a Mission there. Our Embassy has become ineffective and inactive because we are not able to recognise the new regime. This has happened. The new President, Mr. Lule has invited all the Indians to go back and has- promised to pay them compensation if they have lost their property or if the Government has taken over their property. This is the position. Our people have to go there. If our Embassy is ineffective and inactive, there is no use. This stands

on a separate footing. In Kampuchea fighting was going on and we were not able to take a decision. There is no fighting here now. The hon. Minister is here. Our people are suffering. Let the Government come and explain when they are giving recognition to the new regime and help our people.

SHRI HAREKRUSHNA MALLICK (Orissa): Sir, I raise a discussion under Ruie 176 in regard to giving our recognition for the Government of Uganda headed by Prof. Lule who has replaced .the tyranny of Idi Amin. India has positive interests in regard to her thousands of people in Uganda and their property and safety. This will also bring us tangible goodwill from all the African countries with which we share the common fate and fortune as non-aligned nations and nations dedicated to world peace.

In this context I may refer to all the news items published and I may only remind that all these days we have been hearing the horrible stories of Idi Amin and his men, and he has been replaced, which is a great relief to the peace loving nations.

THE VICE-CHAIRMAN (SHRI SHYAM LAL YADAV): Your point is clear.

SHRI HAREKRUSHNA MALLICK: I wonder whether there are some foreign agents who 'want to re-establish him (i.e. Odi Amin) in Uganda. (Interruptions) I demand that our Government should give recognition to the present regime of Prof. Lule. Our Mission should function properly. The property of our people must be safeguarded and our interests and honour in the African continent should be upheld.

REFERENCE TO ACCORDING RECOGNITION OF THE NEW GOVERNMENT OF UGANDA BY THE GOVERNMENT OF INDIA—

THE MINISTER. OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SAMARENDRA KUNDU): Mr. Vice-Chairman, Sir, this is an important question. I can appreciate the concern shown by the hon. Members, Mr. Naidu and Dr. Mallick, and everybody in the House. One of the criteria that we usually follow in granting recognition is whether the Government has effective control. It is true that the present Uganda Government headed by Prof. Lule is in a much better way now than it was in the past. And our recent report is that with the capture of the town of Lira and also the Paikwach bridge,, the stronghold of Idi Amin has fallen. We are still watching the situation very carefully. It is true, Sir, that we have a mission there. Our High Commission is also in constant touch with the present Government. It is not true that the Tanzanian forces have withdrawn. But the Tanzanian Government and other people have given the assurance that they will withdraw their forces as
