## REFERENCE TO THE ALLEGED ATROCITIES ON CLASSES IN MON-BACKWARD CLASSES IN MON-GHYR DISTRICT BIHAR

SHRI HARKISHAN SINGH SUR-JEET (Punjab): Mr. Chairman, Sir, I want to bring to your kind notice through a special mention the question of continuous atrocities against the Harijans and the backward classes in Bihar. This is happening again and again. Not only once, but four or five times we have discussed this question here in this House. In fact it is the landlords  $wh_0$  are ruling in Bihar.

Harijans Backward

SHRI ANANT PRASAD SHARMA (Bihar): Not the Janata Party.

SHRI HARKISHAN SINGH SUR-JEET: Whether it is the Congress Party or the Janata Party, it is the landlords who are ruling in the rural side and the questions of land and wages are the root cause. It is being stated by everybody that nothing can happen without a political will and nothing has happened in Bihar. Even today, the landlords are occupying thousands of acres of land. are evicting the tenants and their houses are being burnt. Here I want to bring to your notice a recent happening. Earlier Belchi was there and  $s_0$  many other places were there. What happened is this. A terrible incident took place in the villages of Cheelkodi, Mushari Tola, Bhagwanpur and Naya Tola in Monghyr District, Bihar, on the 11th of May, 1979. A gang of 400 lathi-weilding goondas belonging to Shri Dharma-nath Singh, one of the biggest landlords of Aloli village, attacked the residents of the above villages in the early hours of 11th May, 1979. They ransacked the huts of the residents, looted their belongings and burnt their dwelling places. Most of the residents of these villages belong to Scheduled Castes and backward communities.

The most deplorable thing was that the Police Chief of the Aloli Police Station, namely Shri Chandrama Singh, along with his armed personnel went to these village before this attack and arrested all the menfolk. Therefore, when the goondas attack—the houses there were only women and children who were attacked and molested by the goonda gang. Nearly 80 huts belonging to these poor Harijans and backward communities were burnt.

Shri Ganesh Shanker Vidyarthi, CPI(M), M.L.A., Bihar Assembly along with others visited the area

## REFERENCE TO THE BOOK TITLED 'MY DAYS WITH NEHRU' BY SHRI M. O. MATHAI,

SHRI BHUPESH GUPTA (West Bengal): Sir, you will remember, previously, I think it was last year, I brought to the notice of the House a certain book titled, 'Reminiscences of Nehru Age' by Mr. M. O. Mathai who used to be the Special Assistant to Pandit Jawaharlal Nehru, and whom we exposed in this House and who had to leave the Government. Naturally, this gentleman is very angry with me.

Now, Sir, I bring to your notice his latest publication, 'My Days With Nehru'. It has just come out. Sir, it seems Mr. Mathai is running amuck to denigrate the public life and to defame the country. How this scandal-monger would be controlled. I cannot say because the laws of the land are such that it is not easy to control such a scandal-monger. But, Sir, we should take note of it.

Sir, in this connection, I am particularly concerned with the activities of the Intelligence Branch, once again reported in this book. And this is

used, Sir, to say all kinds of stories. Now, Sir, I am bringing it to the notice of the House with a view to asking the Government as to what they are going to do with their Intelligence Branch, the IB. It seems, it is being used for all kinds of purposes.

Sir, as you know, in the earlier book, 'Reminiscences of the Nehru Age', Mathai left a page blank with one word, 'She'. And he said this chapter had been withdrawn. What that chapter is nobody knows, and who it means, nobody knows. But this is his style to sell his books. Now. Sir, in the latest book, the same technique he has adopted. We are not concerned with the book. He wants to boost the sale of his books. But we are concerned with our dignity in public life, and how the Intelligence Service works.

Sir, in the prologue of the book, he writes:

"'The story of a Film' is a new chapter I wrote for the second book It contains sensational stuff. The film covers the happening in the Dwaraka Suite of Rashtrapati Bhawan in the afternoon of a day in 1966 and was taken by a senior member of the Government's Intelligence Service well-known to me (now retired). The person involved should thank the stars that the film, by a quirk of fate, fell into my safe hands. I am not including the chapter in this book for the reasons mentioned in the preceding paragraph. The publication of the chapter might also cause international repercussions harmful to the country. The central figure, I mean the other person, in both the chapters is the same."

Now, Sir, what I rise is, how the Government is going to tackle such a matter.
