Setting up of a Thermal Power Project in Rajasthan

517. SHRI KISHAN LAL SHARMA: Will the Minister of ENERGY be pleased to state:

(a), whether it is a fact that Rajasthan Government have submitted a proposal to the Central Government for the setting up of a Thermal Power Project in the State; and

(b) if so, what are the details thereof?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) and (b) A scheme for installation of two units of 110 MW each at Kota Thermal Power Station was sanctioned by the Government in 1976. Work on this project is in progress.

The Rajasthan State Electricity Board have submitted the following proposals for setting up new thermal power schemes.

1. Extension of Kota Thermal Power station by two units of 210 MW each.

2. Installation of a lignite based thermal power station at Palana having two units of 60 MW each.

Both these proposals are under the consideration of the Government.

Production in Dariba Copper Mine

(a) the present production capacity of the Dariba Copper mine in Rajasthan; and

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) The present production capacity of the Dariba Copper mine in Rajasthan is 100 tonnes of Copper ore per day.
