

इस समिति ने अब अपना कार्य स्थगित कर दिया । सरकार ने भी दिल्ली के स्कूलों के शिक्षकों को पदोन्नति के अवसरों पर विचार करने के प्रस्तावों पर फिलहाल आगे कार्यवाही न करने का निर्णय किया है । यह एक ऐसा मामला है जिसका अध्ययन अगले वेतन आयोग द्वारा स्थिति का पुनरीक्षण करते समय अपने आप हो जाएगा ।

(i) the existing staffing position with a view to determining the need of posts at different levels of supervisory and administrative work in the schools; and

(ii) any other incidental and consequential matter arising out of such change over and upgradation.

The Committee has since suspended its function. The Government has also decided not to pursue for the time being the proposal to go into the question of promotional avenues of teachers in Delhi Schools. This is a matter that would be automatically studied when the next pay Commission reviews the position.]
