THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI **BHANU** PRATAP SINGH): (a) Under the Central Sector Scheme of Assistance to the allottees of surplus land, the Rajasthan Government has been given financial assistance of the order of Rs. 94.81 lakhs in 1977-78. No assistance was released during 78-79 under this scheme as the Rajasthan Government has not furnished utilisation certificates for the funds released to them during the years 1975—78.

(b) and (c). 6 major and 2 medium new Irrigation schemes have been sent by the State Government to the Central Water Commission f'or examination and clearance. These are under processing in the Central Water Commission. Details of the schemes are given in the attached statement.
