- (c) Buffer stock for each of these agricultural products is not maintained.
- (d) and (e). In the case of agricultural products, the export is allowed after taking into view that it should not have any impact on the internal supply position and prices in the country.
- (f) Consistent with meeting the indigenous demand for agricultural products at reasonable prices, Government propose to increase their export keeping in view the pace of increase of their production.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERATION (SHRI ARIF BEG): (a) The total extent of land under rubber cultivation in Andaman and Nicobar Islands is 988.45 hectares,

- (b) The year-wise production of rubber in the Islands during 1976-77, 1977-78 and 1978-79 was 59 tonnes, 67 tonnes and 108 tonnes respectively.
- (c) and (d). Rubber production is undertaken on modern lines in 3 estates in the Islands. In the two Government controlled estates, production is being increased by stages in order to attain full capacity within the next one year. Establishment of modern processing factories in the estates of the Islands is receiving attention.
