(b) The State Government had written to the Central Government listing some advantages in locating a Unit for manufacture of telephone equipment, microwave and other devices in Rajasthan. The State Government had stated that industrial land was available at concessional rates and they could consider even more relaxations in this behalf. This offer was duly considered by the Site Selection Committee that was appointed by the Government for selecting site for the location of an electro-mechanical common control switching factory to be set up by the ITI during the> 6th plan period. The Committee has not recommended any site in Rajasthan to be suitable for the location of the switching equipment factory.
