(b) whether it is a fact that the residents living in Sector 'C Albert Square, R. K. Ashram Marg, New Delhi, have not been getting adequate drinking water at fixed hours and water supply frequently breaks down there;

(c) if so, what remedial steps Gov ernment propose to take to set things right and by when Government pro pose to construct the proposed over head tank to give more water to these areas; and

id) whether Government have drawn any long term plan to provide mere water to the Government employees living in the DIZ areas, if so, what are the details thereof and if not what are the reasons therefor?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) Arrangements for providing drinking water supply are quite adequate and it is not a fact that the residents are starving for want of sufficient quantity of water. There is, however, scarcity of water, in general, in Delhi during summer season. (b) No, Sir. Whatever quantity of water is received in the sump, from where water is pumped to overhead tank, is distributed to the quarters.
