**Violation of the Industrial (D&R) Act,

against whom these cases are pending?

mentation of the Plan programmes if no
machinery has been set up what are the
reasons therefor?

THE MINISTER OF STATE IN THE
MINISTRY OF PLANNING (SHRI
FAZLUR REHMAN): (a) The enclosed
statement indicates the targets and
achievements in the three Annual Plans
1971-77 to 1978-79.

Annual Plans 1976-77 to 1978-79. [See Appendix CIX, Annexure No. 58],

(b) Yes, Sir.

(c) The Plan programmes in the public sector are implemented through the agency of the Ministries and departments at the Centre and in the States and public sector companies, corporations and similar organizations set up for specific purposes. Over the years the machinery for Plan implementation has been evolved and strengthened. It has been realised that in keeping with the priority given to agriculture, rural development and village and small industries in the Sixth Plan new institutional arrangements will have to be made. The nature of the needed arrangements and the measures to give effect to them are indicated in the Draft Five Year Plan—1978—S3. Steps have been initiated in this direction.

Employment provided in the Khadi and Village Industries

1144. PROF. RAMLAL PARIKH: Will the Minister of INDUSTRY be pleased to state:

(a) what is the employment provided in the khadi and village industries during the last two years State-wise;

(b) what are the details of the wages paid to the Khadi and village industries employees in different States during the same period; and

(c) what steps Government propose to take to expand the khadi and village industries in the country?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI JAGDAMBI PRASAD YADAV): A statement is attached. [See Appendix CDC, Annexure No. 391.

(b) Detailed information in respect of the wages paid to the Khadi and Village Industries employees in different States is not available.

(c) There are at present 25 Khadi and Village Industries under the purview of Khadi & Village Industries Commission and various programmes for their development have been and are being implemented. A Working Group on Khadi & Village Industries was constituted by the Government to recommend future strategy, policy and programmes for the development of these industries. The Working Group has submitted its recommendations which will be implemented as soon as decisions are taken thereon.

Manufacture of Soyabean products by multinationals and large houses

(a) whether it is a fact that large houses and multinationals have been allowed to set up units for the manufacture of soyabean products;

(b) whether it is a fact that certain applications from the large houses and multinationals for setting up units for Soyabean processing were rejected in the year 1977 if so, what were the reasons therefor;

(c) to what extent the small producers of Soyabean products have been affected; and

(d) what is the number of big companies which have been issued licences to manufacture Soyabean products since January 1979?
