which only at 70 stations thig service is now rendered departmentalism. With the new decision, the number of stations having full departmental 'catering will increase to about 110 stations. Similarly, 45 pairs of trains at present are having departmentally managed mobile catering service and 19 more trains will be brought under departmental management.

Departmentalisation is being introduced to provide better catering facilities to the travelling public. Extension departmentalisation to more stations is expected to be commercially viable as at these stations there is already a nucleus of departmental organisation and the additional cost will be comparatively less. All out efforts will be made to ensure that mobile units on new trains also run on commercially viable lines. In the year 1977-78, departmental catering on Indian Railways earned a profit of about Rs. 68 lakhs, though it was limited to a iew stations and trains.
