nel on 20th January, 1979 at the Kingsway Camp Police Lines caused spreading of injurious gas in the thereby causing great discomfort to the residents; and

(b) if so, what steps Government have taken to check recurrence of such incidents?

THE MINISTER OF STATE IN THE MINISTRY OF HOME **AFFAIRS** S. D. (SHRI PATIL): (a) On 20th January, 1979, a routine tear gas exercise was conducted by the Delhi Police in the New Police Lines. Because of *tougy weather and still air the tear smoke could not rise as it should have and kept floating at a low level. This caused irritation and discomfort to the residents and passersby in the neighbouring area. There was no misfire of tear gas shells.

(b) Such exercises have been conducted over the past 20 years but there has been no complaint of discomfort being caused to the residents of the neighbourhood. The parade ground is big enough and tear smoke dissolves in the area itself.

Permission to spread RSS activities outside India

Finalisation of the Sixth Five Year Plan

714. SHRI SAWAISINGH SISODIA: SHRI GURUDEV GUPTA:

Will the PRIME MINISTER be pleased to state:

- (a) whether there has been an inordinate delay in the finalisation of the Sixth Five Year Plan; and
- (b) if so, what are the reasons. therefor?

THE MINISTER OF STATE IN THE PLANNING (SHR) MINISTRY OF FAZLUR RAHMAN): (a) and (b) There has been no under delay. The Draft Five Year Plan for 1978—83 was submitted by the Flanning Commission to the National Development Council in March 1978. The Council directed the Commission to finalise the Plan in consultation with the States. The process of preparing draft plans of States on the basis of the draft national plan, identification of projects. elaboration of programmes, and examination of all these by the Planning Commission took some months, as had been expected. Meanwhile a Committee had been appointed by the National Development Council to consider various aspects of Centre-State financial relations with reference to the Plan. The Seventa Finance Commission's recommendations having been received the NDC Committee was able to complete its work. The NDC itself has now determined the allocation of Central plan assistance between States. This will enable the States plans to be finalised. The final Plan is expected to be placed before the National Development Council in May 1979.
