(9) the appointment of foreign personnel in both executive and technical capacities will be permitted for the specified period₃ considered essential for each post. The appointment ofthese technicians will however, be formally cleared with the Government of India.

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRIMATI ABHA MAITI): (a) and (b) Special steps have been taken to improve the working of Scooters India Limited during the last one year relating to improvement in productivity, quslity control, marketing and after-sales service. These measures are leading to progressive improvement in production. The of scooters/ power packs manufactured in December 1978 and January 1979 were 3182 nos. and 4220 nos. respectively as compared to 2511 nos. in November 1978.

Deteriorating condition of the Giovanola Binny Plant Cochin

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRIMATI ABHA MAITI): (a) Yes. Sir. The State Government of Kerala has sent a report on this subject in May, 1977.

- (b) Yes, Sir.
- (c) The matter was taken up with the State Government of Kerala. Meanwhile, as the lockout earlier declared by the management of this company was lifted on the 19th of Sept. 1977 and it was reported that normalcy and a sense of mutual cooperation between the management and the workers had been restored. It was decided to watch further developments. The workers' union of the company have, however, submitted another memorandum on the 8th of November 1978, requesting Government to cause! an investigation into the affairs of the company. The State Government of Kerala have been requested to send a complete report and also to indicate if they desire to take over the management of the company so that Central Government can take further suitable action in the matter.

Additional quantities will be imported as and when necessary, A close monitoring on price trends is also being undertaken.
