(f) whether any step has been taken to prevent such accidents in the coal mines of the Singareni Collieries and if so, the details thereof?

THE MINISTER OF PARLIAMEN-
TARY AFFAIRS AND LABOUR
(SHRI RAVINDRA VARMA): (a) and
(b) A fatal accident took place at
Prakasam Khani No. 2 Incline Colliery in
Manuguru coalfield of M/s. Singareni
Collieries Company Ltd. on 31st
December, 1978 resulting in the death of
six persons and serious injuries to three.

(c) Yes, Sir.

(d) and (e) Enquiries have revealed that while loading of coal and re-
erection of supports was going on at
a junction of galleries, a mass of
sandstone and shaly sand stone parted
and fell off false bedding planes and
a slip from the roof at a height of
2.4 to 2.7 metres. None has been held
responsible for the accident.

(f) The management has been advised
to—

(i) create a special cell on strata
control to decide on the type of
supports to be provided;

(ii) to leave sufficient thickness of at
least 76 cms. of coal in the roof; and

(iii) form three way junctions.

The management has also been ad-
vised to consult Central Mining Re-
search Station or other similar Institutes
on problems of strata control/ roof
support and other mining problems in the
different mines of Singareni Collieries
Company Limited.
