other instance of a drug item manufactured without specific approval by M/s. Pfizer has come to the notice of the Government. However, this will be further verified at the time of the consolidation of the licences in terms of the New Drug Policy.

Canalised raw materials have been released in favour of M/s. Pfizer and M/s. Glaxo Labs. in accordance with the policies prevalent from time to time.

- (b) The range of products manufactured by M/s. Indian Schering and M/s. C. E. Fulford require both canalised as well as non-canalised items. Therefore, the question of their production coming to an end as a result of the embargo on supply of canalised raw materials, does not arise.
- (c) Information to the extent possible is being collected and will be laid on the Table of the House.
  - (d) Does not arise.
