Will the Minister of INFORMA-TION AND BROADCASTING pleased to state:

- (a) whether it is a fact that Government have decided to set up a children's film complex near Bombay; and
- (b) if so, what are the details in this regard?

THE MINISTER OF INFORMA-TION AND BROADCASTING (SHRI LAL K. ADVANI): (a) and (b) The Children's Film Society, India, have submitted a scheme for establishing a Complex at Bombay, which is being processed by the Government. scheme involves construction of Complex, consisting of a theatre, two dubbing theatres, one rerecordingcum-music room, one preview theatre and four editing rooms.

Agitation by the workers of Mazagaon Docks

THE MINISTER OF STATE THE MINISTRY OF DEFENCE (SHRI SHER SINGH): (a) and (b) Government are aware of the new! item which appeared in the Hindustan Times dated the 30th December, 1978, which, however, pertains to the wage revision demands of the officers of Mazagon Dock and not workmen. The matter regarding the demands for revision of wages and allowances the officers of Mazagon Dock is under Government's consideration.

Availability of crude oil from Kuwait

882. SHRI F. M. KHAN: Will the Minister of PETROLEUM, CHEMI-CALS AND FERTILIZERS be pleased to state:

- (a) whether it is a fact that the Indian Oil Corporation team which visited Kuwait recently to arrange for additional supply of crude oil has drawn blank, whereas, it was expected that Kuwait may supply at least two million tonnes of crude oil to make up the gap of 2.7 million tonnes in the tie-ups for 1979;
- (b) if so, what are the reasons for Kuwait's showing inability to supply any more crude oil to India during 1979; and
- (c) what is the total amount of expenditure incurred by Government on the visit of the Indian Oil Corporation team to Kuwait?

THE MINISTER OF PETROLEUM. CHEMICALS AND**FERTILIZERS** (SHRI H. N. BAHUGUNA): (a) No, Sir. An Indian Oil Corporation (IOC) Team visited Kuwait in December. 1978 to arrange for supply of petroleum products and not of crude oil.
