The salient features of these guidelines are set out in the statement. While R. B. I. has issued guidelines to commercial banks which have been given adequate publicity in newspapers etc. banks are also expected to familiarise their clientele with the relevant instructions,

Statement

Salient features of the guidelines ed by R.B.I, on 12th December, 1978 in regard to bank credit to artisans, village and cottage industries and small scale industries

- 1. Credit upto Rs. 25,000|- to this subsector should be sanctioned a3 a composite term loans for equipment finance and working capital or for both with repayment period of 7 to 10 years or more,
- 2. Ordinarily, there should be no insistence of margin for this category.
- 3. Maximum rate of interest of H per cent in backward districts and 11 per cent in other areas will be charged in respect of composite term loan.
- 4. Term loans to tiny sector will carry an interest rate of 11 per cent. For working capital credit limits between Rs. 25,000]- and 1 lakh, bank_s may charge interest at the rate of 12J per cent p.m.
- 5. All proposals upto Rs. 1 lakh should be disposed of within a period of 30 days. Besides, banks have been advised that loan applications upto Rs. 25,0001- should be sanctioned without reference to any higher autho. rity and necessary administrative machinery should be created so as to ensure adequate delegation of powers-in the banking system at the district level itself.]

Strengthening of Indian Airlines and Air India fleet of Aircrafts

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): (a) Yes, Sir.

(b) and (c) Air-India have placed orders with the Boeing Company, USA, for purchase of one B-747 aircraft in replacement of the one lost in accident on 1-1.78 at an estimated cost of Rs. 41.77 crores. In addition Air-India have placed orders with the Boeing Company for purchase of three B-747 aircrafts at a total estimated project cost of Rs. 148.44 crores in foreign exchange and R3. 10.50 crores in Indian currency.

Indian Airlines have placed an order for purchase of one A300B2 Airbus air. craft at a project cost not exceeding Rs. 35.72 crores. Government approval has also been given for the purchase of one B-737 aircraft by Indian Airlines from M]s. Boeing Company, USA, at a cost not exceeding Rs. 10.00 crores in replacement of the one lost in accident in December, 1978. Besides,, Indian Airlines have submitted a proposal for purchase of two more Airbus aircraft from M|s. Airbus Industries, France and 6 Boe-ing-737 aircrafts from Boeing Company USA, which is presently under consideration of Government.

Export of items of mass consumption

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERATION (SHRI KRISHNA KUMAR GOYAL): Government's consistent policy regarding exports of essential mass consumption items has been to regulate the exports in the light of the supply,, demand and price position and other relevant factors, so as to minimise the social cost of the exports. Accordingly, on the basis of assessment of the relevant factors, export of different items of mass consumption have been permitted by Government during the year.

(b) The main items of mass con, sumption, exports of which have been allowed by Government during 1978-79, and the volume of exports (where available) are as follows:
