- (c) what steps Government have taken to ensure that these multinationals are not allowed to function till they have Indianised their capital as per the requirements of FERA?

THE MINISTER OF STATE THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) No, Sir.

(b) Details of the proposed celebration are being worked out in consultation with the concerned Minis. tries/Departments of the Central Government/State Governments and related organisations.

important cities of Airlinking of the Rajasthan

1039. SHRI BHIM RAJ: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether Government propose to link the important cities of Rajasthan by air in the near future;
- (b) whether any specific time-bound programme has been finalised; and
- (c) if so, what are the details thereof?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI SHOTTAM KAUSHIK): (a) Jaipur, Jodhpur and Udaipur are already covered by air services operated by Indian Airlines.

Ajmer, Jaisalmer, Bikaner, Kota and Abu Road in Rajasthan, are included in the list of 50 new population centres recommended by an expert Committee on Third Level Air Services appointed by Government.

(b) and (c) The Report of the Committee is under examination of the Government.

Sale of confiscated goods

1040. DR. V. P. DUTT: SHRI NARASINGHA PRASAD NANDA: SHRI BHOLA PRASAD:

Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that confiscated goods are being sold by the custom officials themselves at counters opened by them;
- (b) what is the date when the sale of such goods started at various places and what is the value of goods sold on the first day of the sale at various places;
- (c) what are the reasons for allowing the sale of goods through customs officials and not giving the goods to cooperatives in the country for sale as was the practice earlier; and
- (d) whether it is also a fact that thegoods thus sold at customs counters have reached the black market at other places and if so, what measures are proposed to be taken to check the malpractice?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) and (b) Yes, Sir. The recent instructions issu_ ed on 1-12-1978 provide inter-alia for disposal by retail sale, of heterogeneous consumer items seized in small lots and confiscated to Government, (excluding watches) after meeting the requirements of the Government Departments and educational and research institutions, as the case may be.

It is reported that action to fix sale prices and make necessary administrative arrangements for sale of these items has been already initiated. Information regarding the proceeds from the sale of these items in different collectorates is not readily available.

- (c) The object of allowing disposal of the above items through retail sale is to expedite the clearance of the stocks and also to ensure that the goods are sold directly to bonafide consumers.
- (d) No, Sir. Reports received by Government do not provide any such indication.

Disposal of smuggled goods

- 1041. SHRI F. M. KHAN: Will the Minister of FINANCE be pleased to state:
- (a) the total value of smuggled goods seized during 1978 in the country, and
- (b) the quantity and value of smuggled goods disposed of during the same period?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) The value of smuggled goods seized during the year, 1978 was about Rs. 30.33 crores.

(b) The value of confiscated smuggled goods disposed of during the same period was about Rs. 6.03 crores.
