On 17th February, 1979, the index was 161.3 as compared to 167.8 September 1978 and 178.7 in February last year.

- (c) The Government have taken a number of measures to ensure prices are maintained at reasonable levels and the purchase of cotton is activated to the advantage of the growers. These measures include:
 - (i) Relaxation in stock limits to be held by mills and traders.
 - (ii) Removal of restrictions on intra-trade transactions.
 - (iii) Enlargement of the role of the Cotton Corporation of India to include not only purchases NTC, but also commercial purchases for non-NTC mills and buffer stocking.
 - (iv) Permission to the CCI and Gujarat State Cooperative Marketing Federation for export of 2 lakh bales of previous season's cotton which was not saleable in the domestic market.
 - lifting of the ban on (v) The export of Bengal Deshi cotton, soft cotton waste and yellow pickings and the permission given for export up till now of 70,000 bales of Bengal Deshi Cotton.
 - (vi) Permission for the export of 1.5 lakh bales of Staple Cotton of specified varieties during the current cotton season through Apex the Marketing Societie_s of concerned cotton growing States and CCI.
 - (vii) Imposition of import duty of Rs. 1.32 per kg. and a corresponding hike in excise duty in respect of viscose staple fibre.
 - the earlier (viii) Rescinding of order enjoining on the industry the

compulsory use of minimum of 10 per cent of non-cotton fibres.

(ix) Stoppage of import of cotton from abroad to the detriment indigenous cotton growers.
