- (b) whether collected articles have also been selected for the Project; and
- (c) what is the amount of royalty prepaid for these collected articles?

## World Conference of children

- 237. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:
- (a) whether Government have taken any decision in regard to the holding of the first world conference of children during the current year;
- (b) whether the date and venue of the conference has been finalised;
  - (c) if so what are the details thereof;
- (d) what facilities are proposed to be provided to the participants in the conference; and
- (e) whether the national and inter national airlines have been requested to provide free passage to the chil dren participating in the conference?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND CULTURE (SHRIMATI RENUKA DEVI BARKA-TAKI): (a) to (d) An international conference of children is being organised at Delhi by the International Union for Child Welfare from 13 to

- 23 November, 1979. The Government of India is not associated with the organisation of the conference itself. However, moral support, along with a token financial assistance is proposed to be extended to the organisers of the proposed conference.
- (e) The request of International Union for Child Welfare for free passage to overseas participants was ie-ferred to the Ministry of Tourism and Civil Aviation for consideration. The Indian Airlines and Air India while indicating their inability to provide free passage have suggested availing of the existing concessions for overseas children.
