Issue of commemorative stamps to honour the memory of Sindhi martyr

1093. SHRI KRISHNA KRIPALA-NI: Will the Minister of COMMUNI-CATIONS be pleased to state:

- (a) whether Government have received representation from Sindhi community for the issuance of a special stamp to honour Sindhi martyr Hemu Kalani who was hanged for his participation in the fight for India's liberation;
- (b) whether Government propose to issue a special stamp in his memory; and
- (c) if so, by when the stamp is likely to be released?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICA-TIONS (SHRI NARHARI PRASAD SUKHDEO SAI): (a) Yes, Sir.

(b) and (c) The proposal was placed before the Philatelic Advisory Committee in its meeting held on 31st December, 1977 but was not recommended.

- (c) if so, what are the details thereof;

- (d) if not, what are the family members included under the expression "unmarried children":
- (e) whether the Delhi Development Authority has given the correct connotation of "unmarried children" in the affidavit form; and
- (f) if not, what steps are being taken in this regard?

- (d) to (f) The expression used in the affidavit is "dependent relations including unmarried children". There is no ambiguity in the expression "unmarried children". The D.D.A. has reported that as regards the expression "dependent relations", the matter is being re-examined.
