: :

At present the capacity utilisation of the automotive tyres industry and bicycle tyre industry is 88 per cent and 93 per cent respectively. The tyre industry, like other rubber-based goods industry, has faced a shortage of natural rubber since April' 78. In view of the shortage and rising prices of indigenous natural rubber, Government arranged import of 15,000 tonnes of natural rubber through STC in October, 1978. Further import of 15,000 tonnes of natural rubber is also being arranged to meet the gap between demand and available supplies.

The automotive tyre industry also faced shortage of some of the raw materials like synthetic rubber and carbon black. Import of synthetic rubber (SBR) is being allowed to actual users on restricted basis to overcome the shortage which occurred due to production problems M/s. Synthetic and Chemicals, Bareilly, which is the only unit manufacturing SBR. There was shortage of carbon black too, on account of strike in one of the units producing this raw material for the tyre indus-Import of this raw material input is also being premitted to actual users on restricted basis.

Due to the high cost of major raw material inputs, the cost of automotive tyres, in general, has gone up. However, as stated earlier, production of automotive and bicycle tyres in the organised sector is increasing and Government are giving all the facilities to actual users to import raw materials which are in short supply.

This included a sum of about Rs. 15 lakhs for inviting tenders and about Rs. 7 lakhs for advertisements for recruitment to the vacancies in the company. These were released to publications like claily newspapers, periodicals, scientific and technical journals, brochures etc.
