- (b) if so, what are the names of the countries to which they belong; and
- (c) what action has been taken against them?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) Yes Sir.

(b) and (c) In the cases detected, Government has taken appropriate action with the cooperation of the countries concerned. In view of the friendly relations and the continuing cooperation from these countries, it would not be appropriate to disclose the details.

Defects in Boeing Planes operated by Indian Airlines

1509. SHRI SATCHIDANANDA: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether there is a general complaint of defects in boeing planes operated by the Indian Airlines: and
- (b) if so, what action has been taken in the matter to make travel safer for passengers?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURU-SHOTTAM KAUSHIK): (a) and (b) No. Sir. There are normal mechanical snags noticed during the operation of all types of aircraft which are reported by the opertaing crew and are taken up for rectification promptly. The B-737 aircraft is no exception. All major defects reported by pilots or those observed on ground are brought to the notice of Inspection Officers of the Civil Aviation Department, who carry out investigation for further necessary action. In addition defects of repetitive nature are examined in a joint meeting attended by the Indian , Airlines' officials and the Regional Inspection Officers of the Civil Aviation Department. Continuous efforts are thus made to keep the aircraft airworthy and in safe condition.

Import of mutton and vegetables from Kenya and other countries
