Proposals from various State Governments for taking over sick textile units

*335. SHRIMATI AMBIKA SONI: SHRIMATI AMARJIT KAUR: SHRI S. W. DHABE:

Will the Minister of INDUSTRY be pleased to state:

(a) what is the number of proposals received during the last three years from various State Governments for taking over sick textile mills;

- (b) since when these textile mills are closed and how many workers are affected; and
- (c) what steps Government have taken to reopen the textile mills?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) to (c) During the last three years, the managements of 13 cotton mills which remained closed for one reason or the other involving about 24,400 workers have been taken over under the IDR Act or otherwise. Concerned State Governments had drawn the attention of the Government cf India in all these cases. The situation regarding closures has improved over these years as can be seen from the number of closures coming down from the level of 41 in 1976 to 38 in 1977 and 35 in 1978 to only 18 mills remaining closed at the end of January, 1979. The steps that are taken to reopen closed textile mills are governed by the guidelines enunciated in the Statement laid on the Table of the House on Sickness in Industries on 15th May, 1978.

Safeguarding of seniority of Government employees

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have laid down any procedure for safeguarding the original seniority of Government servants when they are placed in newly created cadres and services in various Ministries/Departments of the Government of India;
- (b) if so, what are the details in this regard; and
- (c) if the answer to part (a) above be in the negative, in what manner the seniority of such personnel is protected in their original and permanent cadres and service for the purpose of their future promotions till they are perma-

nently absorbed in the newly created cadres and services?

THE MINISTER OF HOME AFFAIRS (SHRI H. M. PATEL): (a) and (b) Recently Ministries/Departments have been advised to make provision for 'Initial Constitution' of the newly created services/cadres in the Recruitment Rules with the following purposes in view:—

- (i) To provide for a high level screening Committee with a UPSC Member wherever necessary to decide on the fitnes, of the existing incumbents for inducting them into the new cadre;
- (ii) the determination of the inter se seniority of the existing incumbents in the new service; and
 - (iii) the manner in which persons who are not found fit for the new cadre should be dealt with.
 - (c) Does not arise.
