- (a) what is the rate of industrial growth recorded by the Central Statis tical Organization and the estimates made by his Ministry, separately during each month of ApriT"to~ September, 1978 a,3 compared to that of the preceding six mo'iitrrsP~
- (b) whether there is any difference between the recorded rate of growth by the two agencies; and
 - (c) if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI JAGDAMBI PRASAD YADAV): (a) to (c) The following Table shows the index numbers of industrial production as compiled by the CSO, from April to September, 1978 along with corresponding figures for the previous year.

The Ministry of Industry is constantly monitoring trends in industrial production, and from time to time estimates regarding growth rate of industrial production are made by the Ministry based on advance information on production of Selected industries. However, no monthwise estimates are released. For the first six months of the year, the rate of growth estimated by the Ministry was around 8 per cent as against 7.7 per cent released by the C.S.O. For the earlier period April-July, 1978, the Ministry had estimated a rate of growth of "over 7 per cent" ag against the Anal CSO figure of 8.1 per cent. The Ministry's estimates are made about two months in advance of the index released by the CSO and as such some differences in the

mates are only to be expected. However, by and large the two estimates have been fairly close.

Fall in the growth rate of industrial production

1552. SHRI N. K. P. SALVE: WiH the Minister of INDUSTRY be pleas ed to state:

- (a) whether it is a fact that the latest index figures for industrial production during the last seven months indicate that the growth rate in the current year may fall far below the expected growth rate of 8 per cent; and
- (b) if so, what are the reasons for the shortfall?

THE MINISTER OF STATE IN THE MINISTRY OF **INDUSTRY** (SHRI JAGDAMBI **PRASAD** YADAV): (a) and (b) No Sir; according to the index of industrial production compiled by the Central Statistical Organisation, the rate of growth of industrial production during the first seven months of 1978-79 was 7.5 per cent as against the targeted rate of growth of 7-8 per cent set for this year.

Quota of cement allotted to Madhya Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI JAGDAMBI PRASAD YADAV): (a") to (c) The quarterwise allocation of cement and actual despatches to the State of Madhya i-ra-desh during 1978 were as under:—

It will be seen from the above that the actual despatches during the first half of th_e year were less than the allocations while during the se. cond half the actual despatches were higher than the allocations. The shortfall during the first half was due to inadequate wagon availability and road despatches.

(d) Allocation of cement to States is decided upon on quarterly basis depending on the estimated availability during the quarter. The State of Madhya Pradesh has been given an allocation of 1.80 Iakh tonnes plus an ad hoc additional allocation of 20000 tonnes for the period January—March, 1979. An allocation of 1.98 lakh tonnes has been made for the period April—June 1979.
