(b) and (c) The question was considered by Government but it was held that there was a well-developed system of fixation of wages in the plantation industry in each region through bipartite negotiations and there was no need for fixation of uniform wages for plantation workers through Governmental intervention.

Women Plantation Labour

- 1650. SHRI HARKISHAN SINGH SURJEET: Will the Minister of PAR-LIAMENTARY AFFAIRS AND LABOUR be pleased to state:
- (a) whether the Central Government are aware that women workers are denied equal wages in the plantations;
- (b) if so, what steps have so far been taken to ensure equal remuneration to the women workers; and
- (c) what steps have so far been taken by Government against those employees who have denied equal wages to women workers in the plantations?

THE MINISTER OF PARLIAMENTARY (SHRI AFFAIRS AND LABOUR RAVINDRA VARMA): (a) to (c) The Equal Remuneration Ordinance, 1975, later replaced by the Equal Remuneration Act, 1976, was extended to Plantations w.e.f. 15th October, 1975. The Act is fully applicable to plantation? from that date. Complaints have however been received from various unions/organisations, etc., regarding non-payment ot equal wages in plantations. These have been referred to the Governments/Union concerned State who are responsible Territories implementation of the Act in Plantations. Apart from this, State Governments/Union Territories have also been requested from time to timn to ensure effective implementation of the Act.

Discrimination to women labour In payment of wages

1651. SHRI HARKISHAN SINGH SURJEET: Will the Minister of PAR-

- LIAMENTARY AFFAIRS AND LABOUR be pleased to state:
- (a) whether the Central Government are aware that women labour in the agricultural sector are still paid lesser wages than their male counterparts;
- (b) whether the Central Government have given any direction?; to the State Governments to eliminate this

disparity; and

(c) if so, with what result*?

THE MINISTER OF PARLIAMENTARY AND LABOUR AFFAIRS (SHRI RAVINDRA VARMA): (a) and (b) The Equal Remuneration Act, 1976 was extended to the agricultural sectoT with effect from 2nd October, 1977. Plantations had been covered earlier by the Ordinance with effect from 15th October, 1975. Some claims/ complaints regarding non-payment of equal wages in agriculture and plantations have been received by the State Governments who are the appropriate Government for implementation of the Act in this sphere. State Governments/Union Territories have been requested to ensure effective implementation of the Act.

(c) Information received reveals that in some cases claims/complaints have been settled and female agriculture workers have been paid anears of wages.
