†[THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHANTI BHUSHAN): The Sachar Committee Report which runs into 368 printed pages, contains a large number of recommendations concerning both the Companies Act, 1956 and the Monopolies and Restrictive Trade Practices Act, 1969. The implementation of the recommendations involves legislative amendments to a number of sections of these two Acts. These are now under Government's examination and, as soon as the examination is complete, it is proposed to bring forward an amending legislation before Parliament in due course.]
