THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) and (b) The total stock, as on 1-3-1979, of finished drugs viz. Codeine Phosphate I.P., Codeine B.P. and Narcotine B.P. manufactured at Government Opium & Alkaloid Works, Naemuch was 2,198.62 kilograms valued at about Rs. 50.23 lakhs. These drugs are having sold to pharmaceutical industry in India on the recommendations of the Drug Controllers of respective States.

Besides the above drugs, 11,567 kilograms of semi-refined and crude drugs viz. semi-refined morphine and codeine (natural and synthetic) and crude narcotine, thebaine and papaverine, valued at about Rs. 165,63 lakhs, are in stock. These drugs require to be further processed and refined to bring them upto the parmacopoeial standards.

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): The Central Department of Tourism gives annual grant to the concerned State Governments as subsidy for meeting the expenses of the salary of the Warden and Assistant Warden to the extent of Rs. 12 000/- per Youth Hostel which follow the management pattern laid down by the Central De. partment of Tourism. A list these Youth Hostels is attached. (See below). In the year 1978-79 subsidy would be released to the concerned State Governments on the same basis.

The Central Department of Tourism also gives Grant-in-Aid of Youth Hostels Association of India of Rs. 10,000/- as annual grant-in-aid towards meeting their administrative expenses on pay and allowances of the staff. Subsidy for the year 1978-79 to the Youth Hostels Assocation of Inida is being released.

(b) Youth Hostels Association of India is a voluntary organisation capable of undertaking youth activities on an organised basis on national scale and fulfills a great social purpose. It is an organisation which within its limited means has been able to introduce facilities for youth travel at various places in the country. The Grant-in-aid to the Youth Hotsels Association of Inida is governed by Rule 148(B) of the General Financial Rules.
