THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT): (a) No. Sir.

(b) Does not arise.

Sale of potatoes and sugarcane in U.P.

*417. SHRI SHIVDAYAL SINGH CHAURASIA:

SHRI KHURSHED ALAM KHAN:

SHRI JAGDISH JOSHI:

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether it is a fact that there is distress sale of potatoes and sugarcane in some of the districts of Uttar Pradesh during the current season;
- (b) whether it is also a fact that this situation is created due to the high cost of transport;
- (c) what is the progress made in the establishment of a potato starch factory in Farrukhabad; and
- (d) what steps Government have taken or propose to take to save the agriculturists from this situation?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH): (a) No specific report of distress sale of sugarcane in some of the districts of Uttar Pradesh has been reported during the current season. As regards potatoes, in some U.P. markets it is being sold at a very low price.

- (b) No, Sir.
- (c) Proposals for setting up potato processing factories are under consideration of the U.P. Government.
- (d) For the current season 1978-79, Government have raised the statutory minimum price payable by sugar factories for sugarcane from Rs. 8.50 to Rs. 10 per quintal linked to a

recovery of 8.5 per cent. The Government of U.P. have fixed minimum price of Rs. 6 per quintal payable by khandsari units in the State during the current season. Export of potatoes is freely allowed. Transport facilities are being provided to the extent, other pressing needs permit.

Development of plots for allotment to public/

- *418. SHRI SITARAM KESRI: Will the Minister of WORKS AND HOUS-ING AND SUPPLY AND REHABILI-TATION be pleased to state:
- (a) whether it is a fact that Government propose to develop plots of land in different sizes for allotment by lots to public in the Union Territory of Delhi: and
- (b) if so, what is the number of plots which are proposed to be so developed, the period by when these plots are expected to be ready for allotment and the areas where these plots are to be developed?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT): (a) Yes, Sir.

(b) Over 30,000 plots of different sizes are proposed to be developed every year in Delhi. They will be allotted to the public by draw of lots and otherwise. It is not possible to indicate any time limit by which plots will be ready for allotment.

Ban on the registration of new group housing societies in Delhi

SHRI M. KADERSHAH:

Will the Minister of WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION be pleased to state:

- (a) under what provisions of law Government have banned the registration of new group housing societies in Delhi from 1973:
- (b) whether it is a fact that the ban is a deterrent factor in floating new group housing societies;
- (c) whether it is not a fact that this ban is against the concept of group housing movement in Delhi in the overall context of the role of the cooperative sector in the national reconstruction programme; and
- (d) whether Government propose to lift the ban on the registration of new cooperative group housing societies?

THE MINISTER OF WORKS AND HOUSING ANDSUPPLY AND REHABILITATION (SHRI SIKAN-DAR BAKHT): (a) Under Section 9 of the Delhi Co-operative Societies Act, 1972, the Registrar of Co-operative Societies is competent to refuse registration.

- (b) Yes, Sir.
- (c) Allowing registration of group housing societies, without any prospect of allotment of land in near future, would be more detrimental to the interests of Co-operative movement.
- (d) Owing to the limited availability of allotable land in Delhi, the DDA is not in position to offer land for new societies. Hence the purpose of registering new societies will not be achieved.

Protection of the Cooch Behar Palace

*420. SHRI JAHARLAL BANER-JEE: SHRI PRASENJIT BARMAN:

SHRIMATI PRATIMA BOSE:

Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

- (a) whether the Central Government have taken any decision to protect the Cooch Behar Palace in West Bengal;
- (b) if so what steps have taken so far in this regard;
- (c) whether any scheme for the utilisation of the Palace has also been drawn up: and
- (d) if so, what are the details thereof?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR PRATAP CHANDRA CHUN-DER): (a) and (b) Yes, Sir. Steps are being taken for the collection and finalization of protection required for issuing notification, declaring the Palace as a monument of national importance under Ancient Monuments and Archaeological Sites and Remains Act, 1958.

- (c) No, Sir.
- (d) Does not arise.
