THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) to (c) A statement is lai don the Table of the Sabha.

Statement

- (a) This Agricultural Prices Commission has recommended a support price of Rs. 245 per quinatal for mustard of fair average quality for the 1978-79 crop (to be marketed in 1979-80) as compared with Rs. 225 per quintal fixed for 1977-78 crop. The recommendation has been accepted by the Government.
- (b) It is hoped the higher price will motivate the farmers to step up production of mustard.
- (c) Support price of jute has been fixed by the Government at Rs. 150 per quintal for W-5 variety in Assam for 1978-79. A.P.C. while making its recommendations on minimum support price takes into account various relevant factors such as cost of production, prices of inputs, prices of competing crops and ruling market prices.

Increase in licence fee of quarters allotted to Central Government employees

*410. SHRI VENIGALLA SATYA-NARAYANA: SHRI PRABHU SINGH: SHRI MULKA GOVINDA REDDY:

Will the Minister of WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION be pleased to refer to the reply to Unstarred Question 654 given in the Rajya Sabha on the 20th February, 1979 and state:

(a) how many times during the last three years, the licence fee of the quarters allotted to Central Government servants has been increased and what is the amount of increase effected in each type; and

(b) what steps Government are taking to provide relief to the low paid categories of the Central Government employees in this regard?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) and (b) Licence fee has been increased only once in last three years i.e. from 1st April, 1978. The increase is 8 per cent of the then existing rate of licence fee in B. C and D (types II to IV residences), 9 per cent in E E1 E2 and E3 (types V to VIII residences) and 11 per cent in hutted accommodation. There is. however increase as also decrease in certain type 'A' (type I) residences which are allotted to low paid em-Such of the employees plovees. whose emoluments are less than Rs. 300/- p.m. recovery is made from them either at 7½ per cent of their emoluments or the standard licence fee whichever is less. In other cases, recovery is made @ 10 per cent of emoluments or standard licence fee whichever is less. There is no proposal at the moment to give any further relief.
