The National Adult Education Programmewas formally launched on 2nd October, 1978. It aims at extension of educational facilities to about 100 million illiterate persons, within a period of about five years. The target for 1978-79, which is also the preparatory year, was 1.5 million. The progress in regard to exact coverage as well as the actual Statewise expenditure against the budget allocations will be known after information from all States and Union Territories has been furnished by them after the close of the financial year.

Common facilities like stair-cases, open ground, paths, installation for water supply and lighting of the common portion have also been provided.
