SHIPPING AND TRANSPORT (SHRI CHAND RAM): (a) and (b) There has b*en some under-utilisation of capacity of the Hindustan Shipyard Ltd. because of lack of orders for building ships. However, the position has improved with the receipt of orders for 3 vessels from Shipping Corporation of India in January, 1979. Orders for 4 more vesseb are likely to be received from the SCI shortly.

Happenings in Indo-China

329. SHRI SITARAM KESRI: SHRI BUDDHA PRIYA MAURYA;

WUI the Minister of EXTERNAL AFFAIRS be pleased to. state what is Government's reaction to the situation reportedly created as a result of the recent flare-up in the Indo-China *vis-a-vis* threat to peace and security in the South East Asian countries?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SAMARENDRA KUNDU): The situation in Indo-China has been tense and inflamed for the last few months. This has caused a setback to the process, which at one time looked hopeful, of cooperative relations being developed in the South East Asian region.

We would like to see peace and tranquility prevail in thi₃ region so that the nations, in their independence, can resume economic and other cooperation in the region. We are in consultation with other countries regarding possible steps that we could all take together to prevent the further deterioration in the situation. The Minister for External Affairs has already made a statement in the House on February 20 on the reported attack by China on Vietnamese territory and the Government of India's reaction thereto.

Hospitality to an M.P. from Fiji by the Indian Council of Cultural Relations

THE MINISTER OF STATE TN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SAMARENDRA KUNDU): (a) and (b) **Yes**, Sir. Some Indian artists have visited South Africa by Indian citizens for cultural organisation of the persons of Indian origin there.

Occasional private visits to South Africa by Indian citizens **for** cultural Or religious purposes had been permitted since many on a very restricted basis. Endorsements for South Africa restricted for a period of three months were granted in such cases on the basis of a written undertaking
