(c) The report, prepared on the occasion of the UN General Assembly Special Session on Beijing +5 held in New York in June, 2000, is a status review of the Platform for Action (PFA) adopted at the Fourth World Conference on Women held in Beijing in September, 1995. The report assesses the progress made in terms of Governmental policies, programmes and initiatives over the last five years in the twelve critical areas of concern related to women's development and empowerment identified in the PFA, namely:—

- 5. Women and Armed Conflict;
- 6. Women and Economy;

The report also incorporates a sample of civil society responses in terms of their work in the critical areas of concern and feedback on governmental action. The report (in English), entitled "Platform For Action — Five Years After — An Assessment", has been supplied to the Parliament Library.

(d) The inputs used in the preparation of the report include the information collected from several Ministries / Departments of the Government, State Governments, UT Administrations, NGOs, women's organizations, research institutes and autonomous bodies. Responses received to a questionnaire circulated by the Department of Women and Child Development to approximately 350 organizations and the reactions expressed in consultation meetings with NGOs organized by the Department were also used. On the basis of information thus collated, the report was compiled and edited by a professional agency under the overall supervision of the Department.
