with the concerned Ministries, requisite modifications would be made.

(b) The required information relating to April-December, 1978 would become available, complete in all respects, by the end of current year only, as in the compilation of statistical data relating to remittances, there is an unavoidable time lag.

Problems of Tibetan Refugees
