Loss suffered by railways for providing travel facilities to COMEX tourists in India

*448. DR. (SHRIMATI) SATHIA-VANI MUTHU: SHRI SHYAM LAL YADAV: SHRI V. VENKA:

Will the Minister of RAILWAYS be pleased to state;

- (a) whether it is a fact that Railways have suffered a huge loss for providing travel facilities to COMEX tourists in India during 1978; and
 - (b) what is the total toss or subsidy given in this regard during the last 3 years?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) and (b) A statement is laid of] the Table of the House

Statement

(b) The organisers (a) and Commonwealth Expedition-9 desired rail arrangements for about 250 passengers in first class for their journey in this country. Since, this number of first class passengers could not be cleared by regular train services, a special train consisting of 5 AC secend class sleeper coaches, was arranged. Since the total number of delegates who were undertaking the journey was found to be only about 120, the special train was subsequently withdrawn and three extra coaches are being provided on regular train services. These passengers are travelling on Indrail passes which are fully paid tickets. The Indian Contingent has also been extended the facilities of Indrail passes. There is, therefore, no loss to the Indian Railways. No special arrangements were made during the previous Commonwealth Ex-peditions as they did not travel by rail on those occasions.

Guidelines for granting lease of Railway land

*449. SHRI JAHARLAL BANERJEE: SHRI PRASENJIT BARMAN: SHRIMATI PRATIMA BOSE: Will the Minister of RAILWAYS be pleased to state:

(a)whether there are guidelines laid down for granting lease of Rail way land;

(b) whether Government are aware that one Shri Shantilal Pandya and his . family have been occupying 80 acres of Railway land at Dahod in the Western

Railway Zone for the last 30 years even after the expiry of the term ox agreement executed between him ana the Railway Authorities on ihe 31st December, 1975; and

(c) if so, what action Government propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) and (b) Yes Sir.

(c) A plot of land, measuring about 80 acres, is being used as a stewage-farm, to absorb the sewage from the Railway Coloney, Dohad. Shri Pandya had been cultivating thij plot of land since 1935, on lease/license basis which was being renewed ed from time to time. Licence agreement for this plot had expired on 31-12-75. Shri Pandya has not accepted the revised licence fee and has also not signed the agreement. He has, therefore, been served with a notice to vacate the railway land.

Introduction of wages fixed by the first Wage Board for working journalists

THE MINISTER OF PARLIAMENTARY LABOUR AFFAIRS AND (SHRI RAVINDRA VARMA): (a) The decisions of the 1st Wage Board for Working Journalists published in

the Gazette of India on 11-5-1957, were set aside by the. Supreme Court on 19th March, 1958. Hence, the question of their enforcement does not arise.

Subsequently, the Government appointed two more Wage Boards and now two Tribunals have been appointed.

Functioning of Industrial Training Institutes in different States

(b) to (d) There are 356 Industrial Training Institutes affiliated to the 1-jational Council for Training in Vocational Trades. State Governments have asked for the affiliation of 65 more institutes which have beer given provisional affiliation for the present.
