Stepping up the production of cooking gas in the country

415. SHRI SANTOSH KUMAR SAHU: Will the Minister of PETRO-LEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether Government propose to step up the production of cooking gas in the country; and

(b) if so, what are the details in this regard?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) Yes, Sir.

(b) Availability of LPG (cooking gas) is expected to improve by 1980-81 with commissioning of:—

(i) Facilities for separation of LPG from Bombay High Associated Gaj;

- (ii) Mathura Refinery;
- (iii) Secondary Processing Facility at Koyali Refinery; and
- (iv) Coke Unit of Bongaigaon Refinery.

It is expected that by 1982-83 the existing estimated demand potential would be fully met by the above availability.

Coverage of cricket test matches

Will the Minister of INFORMATION AND BROADCASTING be pleased to state what steps Government are contemplating to improve the T.V. and Radio coverage of test matches?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI LAL K. ADVANI): In order to improve the quality of the sports commentaries, both Doordarshan and All India Radio have taken a number of steps to streamline the procedure for the selection of commentators for improving the telecast of the test matches. Plans to obtain permanent fixed positions for our cameras and commentators are being worked out; special equipments for 'Slow Motion Display' etc. have also been ordered to enhance the quality of the coverage. Intensive training course for the producers, commentators and cameramen are being organised.

Ad-hoc increase in the royalty of crude oil produced in Assam

(a) whether the Government of Assam have approached the Central Government for an ad-hoc increase in the royalty of crude oil produce in that State to enable them to fill the revenue gap; and

(b) if so, what is the reaction of the Central Government thereto?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) The Government of Assam had requested for a higher royalty based on full posted price of equivalent Middle Eastern crude and need for additional resources for development plans of the State.

(b) It has been decided that the existing rate of Royalty on crude oil and casing head condensate would continue till it is reviewed in 1980.
