## Export Minimum Prices to Virginia **Tobacco Growers**

(a) whether it is a fact that the Virginia tobacco gorwers in the country are paid export minimum prices by the main categories of buyers

- (b) whether these prices paid to the growers are related to the cost of production; and
- (c) if so, what steps Government have taken or propose to take with a view to ensuring remunerative prices to the Virginia tobacco growers in the country?

THE MINISTER OF STATE IN THE. MINISTRY OF COMMERCE, CIVIL. SUPPLIES AND COOPERATION (SHRI ARIF BEG): (a) and (b) The minimum export prices are the prices below which exports are not allowed. These are not the prices at which tobacco is purchased by the trade from the growers. Cogt of production is also one of the factors taken into consideration by the Tobacco Board in recommending minimum export prices for tobacco to the Government.

(c) Introduction of new farm grades and Tobacco Leaf Purchase Voucher Scheme and regulation of production of Virginia tobacco are some of the measures which have been taken by the Tobacco Board so that tobacco growers may get remunerative prices. The Tobacco Board is also working out a scheme for setting up of auction platforms for sale of Virginia tobacco and establishment of auction platforms will greatly help the growers to get remunerative prices for their produce. During periods of excess production of Virginia tobacco, the Central Government also intervened in the market to avoid any abnormal fall in tobacco prices. Excess production of Virginia tobacco in Andhra Pradesh Is also expected during this year and the Government has already directed the STC to purchase 10,000 tonnes of VFC tobacco, on Government account from the growers and growers' co-operatives in addition to 5,000 tonnes which the STC is to purchase on their commercial account.
