## Shortage of staff in the State Bank Of India

285. SHRI MULKA GOVINDA REDDY: Will the Minister of FINANCE be pleased to state:

- (a) whether Government are aware of the acute shortage of staff in various branches of the State Bank of India all over the country;
- (b) if so, -what are the estimated shortage of staff in respect of officers, cashiers and subordinate staff;
- (c) Whether there is a total ban on the recruitment of temporary hands in the Bank;

- (e) what steps Government propose to take to streamline promotions and fresh recruitments to make up the staff shortage and improve customer services?

THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) and (b) State Bank of India has reported that there has "been no acute shortage of staff in various branches of the Bank in the country upto the end of 1977. Circle staff budgets for the year 1^78 are, however, yet to be finalised.

- (c) and (d) Temporary appointments are made in exceptional cases where staff is urgently required to maintain the normal functioning of a branch.
- (e) The bank has already announced promotion.;; to the various grades of staff officers in February last. Staff budgets of the '^'arious Circles will be settled shortly and additional staff wherever neces.sary will be sanctioned and recruited.
