THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): (a) and (b) In the context of the complaints made by the Jawahar-lal Nehru University Students' Union and others from Mav. 1977 onwards about irregularities alleged to have been committed by the University authorities during the period of Emergency and the agitation that followed, resulting in the closure of the University with effect from 3rd November, 1977, the Prime Minister, who is the Chancellor of the University, agreed to hold a preliminary inquiry into the various complaints against the University administration. The strike was thereafter called off and the University started functioning normally.

Papers laid

As the complaints inter-alia pertained to irregularities in the filling up of teaching posts in the University, advice was given to the Vice-Chancellor on November 8, 1977 that pending the inquiry, action to fill up the important posts in the University should be held in abeyance, and in case there is any particular post, the filling of which becomes essential, the University may write to the Education Minister and seek his prior consent. On 6th January, 1978. the Vice-Chancellor wrote to the Chancellor about the filling up of vacancies in various Schools of University. The Chancellor replied that there would be no objection to the filling up of the posts, provided they were advertised and the names of the members of the Selction Committees were sent to him for approval before they began to function. The Vice-Chancellor, subsequently, discussed the matter with the Prime Minister during which he referred to the statutory provision that the panels of experts were to be drawn up by the Executive Council of the University en the recommendation of the Academic Council. As the Chancellor had no intention to interfere with the power of the Executive Council, he Vice-Chancellor the that University may proceed with the

filling up of various positions as proposed. The Selection Committee have accordingly started functioning.
