SHRI ARVIND GANESH KULKARNI (Maharashtra); Sir, I want to support Mr. Maurya. We have given a Call Attention notice on the killings in Agra. Sir, the point is that you have not admitted it but you have admitted some other motion about milk. The Harijans and weaker sections of people are being killed by the Government. Sir, it is in your power to admit this Call Attention notice. I request you to admit this Call Attention motion. Let the House discuss this...

(Interruptions)

MR. CHAIRMAN; Why do four Members speak at a time?

SHRI ARVIND GANESH KULKARNI; Sir, it is a mockery of the law and order situation created by the Janata Government. So, I request that this Call Attention motion should be admitted. Wherever Harijans have been killed, at least special attention should be given by you, Sir, in admitting such motions.

If you d0 not admit that directly, let there be a statement by the Government.

SHRI M. R. KRISHNA (Andhra Pradesh); Mr. Chairman, Sir, we have given a Call Attention notice on this important subject. This thing which has happened in Agra is going to take a very bad turn and it might occur in other parts of the country also. And, therefore, we thought it important and that it would be taken up immediately. But instead of that, the rise in milk price has come up. Sir, you are the custodian of this House and you have got every right to admit this. If you wanted that the Ministry should collect the information and the Ministry should be prepared to come before this House with all the information, even in that case it should not have been delayed. It should not be delayed because the Minister is in the hospital. The Department is there and Agra is not far away. They can collect this information. It is increasing day by day but not decreasing. The military has been called. On the very same day, this motion should have been allowed. It has already been delayed. We would request you, Sir, to take it up immediately with th© Ministry. Let it be taken up in the afternoon.

DR. BHAI MAHAVIR (Madhya Pradesh); Sir, I want to make one submission. It is not for the first time that a subject . . .

SHRI ANANDA PATHAK (West Bengal); Sir, I share the views of the hon. Members expressed here.

MR. CHAIRMAN; I have called Mr. Bhai Mahavir. You please resume your seat.

DR. BHAI MAHAVIR; Sir, it is not for the first time that a subject has been raised without the procedures being followed. I am not going into the merits of the case". By all means, it is a very important subject.

SHRI ARVIND GANESH KULKARNI; in this case, Harijans have Ibeen killed.

DR. BHAI MAHAVIR; You have already spoken. I ifi've a right to make my submission. I am addressing- the Chair.

Why are you disturbing when he is speaking? When you are speaking, you expect the others to be quiet. You should be quiet when others are speaking.

, DR. BHAI MAHAVIR; Sir, what I was submitting is that a question like police firing and casualties is not a party issue. We are not behind anyone else in this. Sir, any hon. Member in this House, if he was not hurt or shocked by the incidents like the one happened in Agra, and continue to happen in other parts of the country, would be unfit for his place here and unfit to be a responsible citizen of the country. Sir, if we do not make a show of it here, it is because we respect the procedures laid down by the Chair and followed by the House all along. Sir, if Calling Attention Notices are given, they have a proper way of being dealt with and you, in your wisdom, are doing it. Then there is another occasion of a

Special Mention, but there is a method for that also. If the Chair expects Members on this side of trie House to respect the procedures laid down by the Chair and being followed, then, Sir, my friends on the other side also should exercise some restraint upon themselves. Taking any occasion through a point of order and trying to bring forth a subject which has not been permitted otherwise, is a practice which we also can follow. It is a game which we also can play. It is not a reflection on the merits of the case, Sir. I am not behind anyone else in demanding a discussion on this matter.

SHRI M._R. KRISHNA: This is an aspersion on the Members who have raised this matter. He thinks we do not know the procedure. I have also raised the same point. It is not that I do not know the procedure.

Such instances of atrocities are being perpetrated on the Scheduled Caste persons throughout the whole country. I would like to suggest

that there should not only be a Calling Attention discussion on the Agra-matter but that there should be a general discussion on the atrocities perpetrated on the Scheduled Caste persons.

SHRI DINESH GOSWAMI (Assam): My friends. Shri Maurya and Dr. Bhai Mahavir, have raised some points on which a ruling is called for. My point is that when you reject a Calling Attention Notice given by the Members, you do not give the reasons for doing so and you do not consult the Members also. Therefore, as a matter of procedure, may I know from you-and I would like to have a ruling on it-, when I feel that the matter is so urgent that it should not have been rejected, to draw your attention to the urgency 0f it- I want to draw the attention of this House to this important matter of following the Rules of Procedure. Mr. Maurya wanted to draw the When attention of the House to this important matter through a Calling Attention Notice, the rejection, behind the back of the Member, if he wants to impress upon the Chair the importance of the matter, has he violated of procedure, which Dr. Bhai any Rules Mahavir alleges. I want a ruling on this quesupon, you, Sir, that this I do urge subject-matter is not only important so far as Agra or U.P. is concerned but that every citizen of this country today is feeling insecure so far as his life and liberty are Are we to remain silent concerned. spectators when Harijans and others are being killed? Has this House not the duty to .discuss these important matters? The price of milk in Delhi is an rise in the important matter but let us also not forget that we have oeen discussing such matters pertaining to Delhi for the last two consecutive and. therefore. days should we not divert our attention to what is happening in the rest of this country? Sir, I feel that you should admit this Attention Motion. Calling And, I do support my learned friend who said that not only should we discuss this Calling Attention Motion but that we should alsa-immediately discuss the law and order situation and the police firings, in the country. In fact, Sir, I feel that the time is ripe when the Government should form a new Ministry which may be named Ministry of Planning for police firings. We should, discuss this Agra matter and connected with it the law and order situation in the rest of the country.

SHRI PILOO MODY (Gujarat); In the Ministry of Police firings Shri Goswami should be appointed a Minis, ter and' Shri Kulkarni a Deputy-Minister.

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA); Sir, the Delhi Milk Scheme (D.M.S.) was established as a departmental undertaking of the Government of India in November, 1959 to supply Wholesome milk to consumers at reasonable prices and at the same time ensure a reason-
