(b) to (d) In pursuance of the National Policy Resolution on Education, Government have been making efforts to ensure the availability of quality books in regional languages to facilitate their adoption as the media of instruction at the university level. While regional languages are being used for a number of university level courses, by and large, professional education and postgraduate courses continue to be through the medium of English. A complete change over to the regional languages would he possible only if a substantial majority of the students opt for regional languages as the media.
