Development of tourism in Madhya Pradesh and Maharashtra

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK); (a) As recommended in the Tourism Ministers Conference held in August 1977, the Governments of Maharashtra and Madhya Pradesh have prepared perspective plans of tourism development in their respective States. These will form the basis of discussion at the time of finalising the schemes of the tourism sector of the Five Year Plan of the two States for the period 1978. 83.

Smugg:Iing of foreigrn goods into India through Nepal

- 273. DR. V. P. DUTT: Will the Minister of FINANCE be pleased to state:
- (a) whether Government held any discussion with the Nepalese Prime Minister during his recent visit to India on the issue of checking the smuggling of foreign goods through Nepal borders into the Indian territory; and
 - (b) if so, what was the outcome thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) and (b) No discussion was held with the Nepalese Prime Minister during his recent visit to India on the issue of checking smuggling across Indo.Nepal border. However, an Agreement of Cooperation to control unauthorised trade between the two countries was signed on the 17th March, 1978. The purpose of this Agreement is that effective measures should be taken and cooperation between the two Governments ensured to check unauthorised trade across the Indo-Nepal border.
