THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) Yes, Sir.

(b) It has not been found possible for the Government to accede to the request of the Kerala Government for withdrawal of excise duty on electricity.

above will be ascertained and laid, on the Table of the House.
