

mended that the posts of Research Assistant and Senior Research Assistant should be merged and be designated as Research Assistant and given the scale of Rs. 210-30-450-575. Three more scales reaching a maximum of Rs. 2000/- were recommended for scientists by the Committee together with a provision for higher pay for eminent scientists. In contrast to this, the Government decided to establish an Agricultural Research Service with a minimum pay scale of Rs. 700—1300 and with a possibility of scientists reaching a scale of Rs. 3500/- per month on the basis of assessment of their work once in five years by the Agricultural Scientists Recruitment Board. The promotion to the next higher scale is irrespective of the occurrence of vacancies. The retirement age was also raised to 60. Similar provisions for promotion to the next higher scale on the basis of appropriate assessment once in five years and a higher retirement age of 60 were introduced for technical services. The large number of young research assistants were given opportunities for direct induction into the Agricultural Research Service on the basis of assessment, in case they possessed the requisite educational qualifications. The former scale of Senior Research Assistant (Rs. 550—900) was designated as Scientist-S and all scientists belonging to this category are screened for adjustment in S-I Rs. 700—1300 irrespective of the length of service. Thus the scientific and technical staff have excellent opportunities now- for career advancement without worrying about vacancies and recurrent applications for jobs.

World Bank aid for construction of houses by the Housing and Urban Development Corporation

Statement

The Housing and Urban Development Corporation is negotiating with the Delhi Development Authority for a few pockets of land in the Connaught Place area, a project which was originally ordered. It was not found suitable and further negotiations were held to identify the possible areas for taking up a low cost housing project to be implemented by HUDCO.

HUDCO has prepared alternative layout plans and building designs for the four pockets now being offered by the D.D.A. The layout plans are based on a Cluster Concept providing adequate open spaces for outdoor living. The designs provide for about 20 sq. mts. of plinth area per dwelling unit. These will be two-storied blocks with either attached terraces on the first floor or with possibility of expansion on the ground/first floor. The structure will be of load bearing brick walls.

The World Bank has not offered any aid for this scheme.

HUDCO has been negotiating with the World Bank for a line of credit for taking up 'sites and services schemes' through the various State housing agencies in India. The negotiations have been in progress for quite some time and recently in October last, a Team of World Bank Officials visited HUDCO and held detailed discussions with its officers. The Team also visited some Sites and Services Projects already sanctioned by HUDCO for the Madhya Pradesh Housing Board at Bhopal and Durg. The reaction of the World Bank to the proposal of HUDCO for making available a line of credit for such projects is still awaited.
